

Shipping Policy (Please Read)

Only an adult over the age of 21 can take receipt of wine deliveries. Whenever possible, we strongly encourage you to use a commercial business address to assure the fastest delivery time. If no one over the age of 21 is available to receive the package, one subsequent attempt to deliver will be made at no expense. Additional delivery attempts may require an additional shipping charge. Verotto uses approved packaging for all wine deliveries. In the unlikely event of damage, contents must be verified as damaged prior to receipt. Verotto will make every effort to process orders received before 11 AM PST, Monday through Friday, before the close of the following business day. In some cases, orders may require as long 72 hours for processing (regardless of requested shipping service). The order department is open Monday through Friday from 9:00am to 4:30pm. Orders are not processed on weekends. Orders received after on Friday will be processed on Monday. We appreciate your input. Please feel free to contact us with any problems.
